EXECUTIVE SUMMARY

Utah is committed to using data to evaluate and inform efforts to make homelessness rare, brief and non-recurrent in the state.

MAKING HOMELESSNESS RARE

The overall number of Utahns experiencing homelessness has largely remained stable.

- The 2019 Point-in-Time (PIT) count showed a decrease of 2.7 percent in the number of people counted as literally homeless situations on a single night in 2019.
- Comparing the PIT to the most recent estimate of the state's population by the U.S. Census Bureau reveals that 9 out of every 10,000 people in the state were experiencing homelessness on the night of the PIT. This rate has decreased since 2015, from approximately 10 out of 10,000 people.
- The annual count of individuals accessing emergency shelter or transitional housing produced by the Utah Homeless Management Information System (HMIS) showed an increase of less than a half percent when compared to the previous year.
- Of individuals in the HMIS annual counts, 59 percent were experiencing homelessness for the first time. The high numbers of first-time homeless individuals suggest the need for identifying additional effective ways of preventing initial instances of homelessness.
- Homelessness is a statewide issue. Approximately 66 percent of homeless individuals were found in Salt Lake County Continuum of Care (CoC), 26 percent in Balance of State CoC, and seven percent in Mountainland CoC. Data from both the PIT and HMIS demonstrate this distribution.

MAKING HOMELESSNESS BRIEF

Length of stay in emergency shelters decreased but remains an area for improvement.

- The statewide average length of stay in emergency shelter, as recorded in HMIS, was 52 nights, a decrease of 3.6 percent when compared to the previous year.

MAKING HOMELESSNESS NON-RECURRENT

The numbers of individuals being permanently housed and those returning to homelessness after being housed are moving in positive directions; however, there is still a need to improve in these areas. There are ongoing efforts to improve the accuracy of the data used to evaluate this goal.

- When compared to the previous reporting year, the number of individuals exiting homeless services to permanent housing increased.
- The rates of individuals returning to homelessness within two years decreased when compared to the previous year.
- The number of chronically homeless individuals reported on the PIT rose from 306 to 512. This increase is largely the result of an effort by the Balance of State and Salt Lake County CoCs to better align their methodology for determining chronic status with guidelines and definitions provided by the U. S. Department of Housing and Urban Development. Mountainland CoC made the same adjustment in 2018 (see page 17).
- The system is highly effective in serving the most vulnerable, with 92 percent of individuals who are enrolled in permanent housing projects other than rapid rehousing either exiting to or retaining permanent housing within the last reporting year (see page 16).

HOMELESS DATA DASHBOARD

In 2017, the Housing and Community Development Division, in partnership with the state’s Continua of Care (CoCs), launched a new data dashboard to make Utah’s latest homelessness data available to the public and service providers (see “Utah’s Approach to Homelessness” to learn more about CoCs). The data is searchable and sortable by date, location, service provider and more. The ability to access the most up-to-date information from around the state should help cities, counties, the state and nonprofit service providers to make wise policy and programming decisions and to react to changes and trends quickly.

Please note that the information in the dashboard can change over time because providers can back-date or change data entered into the system to improve data quality. Therefore, data pulled at a certain point in time for a printed report may differ from the data that appears in the dashboard at a later date. Data in the dashboard is generally updated monthly.



Homelessness Data Dashboard

The scope of homelessness is difficult to measure and therefore some data may be duplicated. In order to measure this population, community leaders must rely on a variety of fluid data sources to inform them about trends, demographics, and outcomes. It should be noted that not all service providers enter information into the Utah Homeless Management Information System (UHMSIS) due to privacy laws or because they are not receiving funding that requires them to participate.



OPERATION RIO GRANDE

Operation Rio Grande launched August 14, 2017, with a three-phase plan to restore public safety in the Rio Grande District of Salt Lake City, after drug use and violence reached a tipping point in July 2017. As each phase progresses, the environment in the Rio Grande area improves for the individuals seeking supportive services to overcome homelessness. A dashboard report, updated monthly, is found at operationriogrande.utah.gov and tracks the outcomes for each phase.

The common goal to prevent and minimize homelessness is measured in two key areas.

1. Reduce the length of time people need shelter from the SFY 2017 baseline of 48.8 days

Results:

- 43.8 days for SFY 2018
- 46.2 days for SFY 2019

2. Increase the number of successful exits from the shelter to housing from the SFY 2017 baseline of 233

Results:

- 274 in SFY 2018
- 263 in SFY 2019

PHASE 1: PUBLIC SAFETY AND RESTORING ORDER is measured by comparing part one offenses (serious or frequent crimes) to a three-year average. In June 2019, part one crimes in the Rio Grande area were down 36 percent compared to the three-year average.

PHASE 2: ASSESSMENT AND TREATMENT supports people struggling with mental illness and drug addiction so they can return to a path of self-reliance. From August 2017 to June 2019:

- 275 treatment beds have been added
- 244 behavioral health assessments have been completed
- 146 individuals have pled into the Drug Court program
- 444 sober living residential beds have been added
- 569 individuals were placed in sober living

PHASE 3: DIGNITY OF WORK prepares and connects individuals to income that supports housing. From November 2017 to June 2019:

- 233 individuals became employed
- 595 job seekers developed an employment plan

Funding for short-term and long-term housing supports have achieved the following from August 2017 to June 2019:

- 661 individuals diverted from emergency shelter to immediate alternate housing arrangements
- 185 individuals have been housed in long-term housing and 348 served in short-term housing

UTILIZATION OF HOUSING RESOURCES

BED UTILIZATION

On January 23, 2019, each of Utah's Continua of Care carried out the HUD-mandated Housing Inventory Count (HIC). The HIC compares the number of individuals spending the night in homeless services programs to the number of beds available in those programs on a specific night. This enables communities to generate a snapshot of their homeless service system's capacity and the extent to which those resources are being utilized.




2019 BED UTILIZATION RATES



THE INTERSECTION OF INTERGENERATIONAL POVERTY AND HOMELESSNESS

In 2017, the Utah Legislature amended the Intergenerational Poverty Mitigation Act to include evaluation of the intersection between child homelessness and intergenerational poverty (IGP). The following data reflects that connection through housing mobility, utilization of homeless services and use of emergency shelter services among IGP families.






IGP USE OF HOMELESS SERVICES

People in IGP Using Services Tracked in HMIS, 2014-2018




IGP USE OF SHELTER SERVICES

PERFORMANCE MEASURES

For many years, HUD has reviewed the impact of its funds on reducing homelessness on a program-by-program basis. As a result, it has been difficult to gain an accurate and comprehensive community-level understanding of the performance of the homelessness services system. To address this need and comply with the HEARTH Act, HUD has developed several system-level performance measures to be reported on by a Continuum of Care (CoC) as a whole. These measures help CoCs more accurately measure their impacts, successes, and challenges in order to inform strategic decisions in the development of the homeless system. The graphic to the right shows the HUD System Performance Measures that have been identified as particularly significant in considering homeless services in Utah. This report covers the time period of October 1, 2017 to September 30, 2018.





MEASURE 1: LENGTH OF TIME PERSONS REMAIN HOMELESS

This measures the number of clients active in the report date range across emergency shelter and safe haven (Metric 1.1) and then emergency shelter, safe haven and transitional housing (Metric 1.2) along with their average and median length of time homeless. This includes time homeless during the report date range as well as prior to the report start date, going back no further than October, 1, 2012.

MEASURE 2: THE EXTENT TO WHICH PERSONS WHO EXIT HOMELESSNESS TO PERMANENT HOUSING DESTINATIONS RETURN TO HOMELESSNESS



This measures clients who exited street outreach, emergency shelter, transitional housing, safe haven or permanent housing projects to a permanent housing destination in the date range two years prior to the report date range. Of those clients, the measure reports on how many of them returned to homelessness as indicated in the HMIS for up to two years after their initial exit.

POINT-IN-TIME COUNT

On January 23, 2019, each of Utah's Continua of Care carried out the HUD-mandated Point-in-Time Count (PIT). The PIT is a massive effort to count everyone who meets the HUD definition of literal homelessness in a community on a specific night. As a result, the PIT captures people who spent the night in an emergency shelter, transitional housing, or in a place not meant for human habitation. While many factors, from the weather to the way the count is organized and performed, influence the results of any given PIT count, the PIT is a useful tool in calculating the community's need for homeless services on any given night. It is also one of the only tools available for measuring the number of homeless individuals who are not enrolled in homeless service programs. CHRONIC HOMELESSNESS

- One area where there was a large change in the 2019 PIT compared to 2018 was the number of chronically homeless individuals, which rose by 306 to 512.
- This increase coincides with an effort by the Balance of State and Salt Lake Continua of Care, which counted 95 percent of Utah's chronically homeless individuals, to better align their methodology for determining chronic status with guidelines and definitions provided by HUD.
- In previous years, all three of Utah's continua only reported individuals as chronically homeless if their chronic status was supported by data points in the HMIS system.

- While HUD does allow continua to verify the chronic status of individuals counted in the PIT using other data sources, service providers in the community raised concerns that this method did not produce results consistent with their records and by-name lists of chronic individuals. These concerns led Mountainland CoC to stop using the verification process during the 2018 count, and the Balance of State and Salt Lake CoCs followed suit in 2019, opting instead to rely on the information collected for the PIT to determine chronic status.
- When this same methodology is applied to the 2018 PIT data, it results in a revised statewide count of 517 chronic individuals, five more than were counted in 2019.
- While calculating chronic homelessness remains complicated and challenging, the reported increase in this subpopulation reflects a picture of chronic homelessness in Utah that is believed to more closely match the federal definition, rather than an actual increase in the number of people experiencing chronic homelessness.

DATA

The following pages display the results of the PIT for the State of Utah as a whole, for each Local Homeless Coordinating Committee (LHCC) and then for each county. The state of Utah and LHCC profiles include data from the 2017, 2018 and 2019 PIT counts in order to provide some historical context. However, only 2018 and 2019 PIT data is available for the county profiles, as this is the second year that data has been provided at that level.


